HEALTH AND HUMAN SERVICES – CENTRAL REGION

Lord Baltimore Hotel, Baltimore City

June 20 & 21, 2019

The day began with Frances B. Phillips, Maryland Deputy Secretary, Public Health Services, who presented on “The Challenges of Human Services in Maryland.” From there, the class visited the innovative TouchPoint Baltimore at Mondawmin, created by Baltimore Gas and Electric and The Whiting-Turner Contracting Company executives. TouchPoint houses the nonprofits Thread, Baltimore Corps, Center for Urban Families and Invested Impact. Calvin Butler, CEO of Baltimore Gas & Electric, and **Tim Reagan '00**, President and CEO of The Whiting-Turner Contracting Company, described how they created the organization on a diner napkin and grew it into today’s reality. Then, a panel of tenants recounted victories and challenges of the resident organizations since their founding years. Panel members Jackie Caldwell, Past President of the Greater Mondawmin Coordinating Council, Brian Lyght, COO for the Center for Urban Families and Sarah Hemminger, Founder of Thread, awed class members with their modest but heroic community impact stories.

After lunch and a ride across town, the class met Humanim’s **Cynthia Plavier-Truitt '03** and **Diana Ellis '17** at their social enterprise program, Details Deconstruction. Then, from the top floor of the renovated brewing factory which houses Humanim, the class heard a comprehensive history of the rebuilding of the community following the 1968 riots. The day concluded at the Lord Baltimore Hotel with dinner in the Versailles Room and a night in the rooftop lounge.



The next morning, following the “Perceptions and Realities” presentation by the Central Region “Blue” Team, the class took a quick trip to the University of Maryland Medical System where Karen E. Doyle, R.N. gave a comprehensive overview of the history and mission of UMMS, along with tours of the R. Adams Cowley Shock Trauma Unit.

The class then dove into “The Opioid Epidemic: Broad Strategies and Local Impacts” featuring speakers **Jeff Beeson '15** Deputy Director, Washington/Baltimore High Intensity Drug Trafficking Area (HIDTA), Joe Gamble, Sherriff, Talbot County, and Christine Rodriguez, Maryland Harm Reduction Training Institute Manager. The discussion was filled with eye-popping statistics, valid disagreements in methodologies, and depictions of the real-life consequences of devastation wrought by drugs in our communities.

The final stop was lunch and a tour of the Living Classrooms Foundation, founded by the visionary **James Piper Bond '95**. Several staff members and participants explained how the foundation teaches Baltimore’s at-risk youth woodworking, maritime, and life skills, at their self-built workshop facilities on the Harbor’s waterfront. In the session’s debrief, class members were asked how each wished to be not just successful, but ultimately accomplish something significant—a theme which would remain in their minds for the entire program.

Guided by moderator **Brandon Butler, Esq. ‘17**, Allegany County Administrator,



they explored the unique challenges and opportunities of life in Western Maryland. Finally, **Marty Schwartz ‘14** of Vehicles for Change facilitated a presentation on “The Pathway to Prison and Beyond”, where Erica Burke and Anthony Watkins opened their hearts to the class in preparation for the upcoming prison visit.

The class wrapped up the day with dinner at Ristorante Ottaviani in Cumberland, while a few classmates continued the evening with some extracurricular bonding in the city.

Following breakfast, Criminal Justice Day started with a drive to the Roxbury Correctional Institute in Hagerstown where the entire class went to prison. The session began with an overview by class member **Carolyn Scruggs ‘19**, Assistant Secretary of Programs, Treatment & Re-entry, Mike Zeigler, Deputy Secretary Operations MDPSCS, Wayne Hill, Commissioner of Correction, and Casey Campbell, Warden, RCI. The class toured Maryland Correctional Enterprises with stops at various vocational shops, visited a housing unit, and the Happy Hounds Program at RCI. After lunch, the class engaged with a panel of inmates who offered their perspectives on incarcerated life. Debrief was personal, impactful and groundbreaking for many.

The class followed the trail of chicken from farm to market, starting at the Plan B Farm with a tour of a 49,000-chicken poultry house by Mike Levingood, Vice President, Chief Animal Care Officer and Farmer Relationship Advocate, and Steve Levitsky, Vice President of Sustainability, both with Perdue Farms, Inc. Then, and for the first time, the class visited Blackwater National Wildlife Refuge for lunch and a presentation by Marcia Pradines, Refuge Manager, U.S. Fish and Wildlife Service. “Maryland’s Environmental Assets and Challenges” was the topic for a look at the many perspectives on the environment with Professor Walter Boynton, University of Maryland Center for Environmental Science’s Chesapeake Biological Laboratory, Rob Etgen, President of the Eastern Shore Land Conservancy, and **James Lewis, '07**, Ag Agent with the University of Maryland Cooperative-Extension Service.

Staying with the theme of living off the land, the class spent the afternoon and early evening at Lazy Day Farm and Layton’s Chance Vineyard and Winery with General Manager **Jennifer W. Layton '14**, Owner Joseph H. Layton, Jr., and Winemaker William Layton. Straight talk, a tractor ride, and copious samplings of grape product made for a memorable evening.

The next morning began with the Eastern Region “Orange” Team’s “Perceptions and Realities” presentation. That was followed by a tour of Perdue’s Salisbury Processing Facility,



the original facility where the Perdue brand was born in 1968. Then, the class listened to a briefing by Randy Day, CEO, Perdue Farms, on “Perdue and Its Future” at the Guerrieri Academic Commons at Salisbury University.

Lunch was hosted by Salisbury University’s proud president and current class member, **Charles “Chuck” Wight '19**. 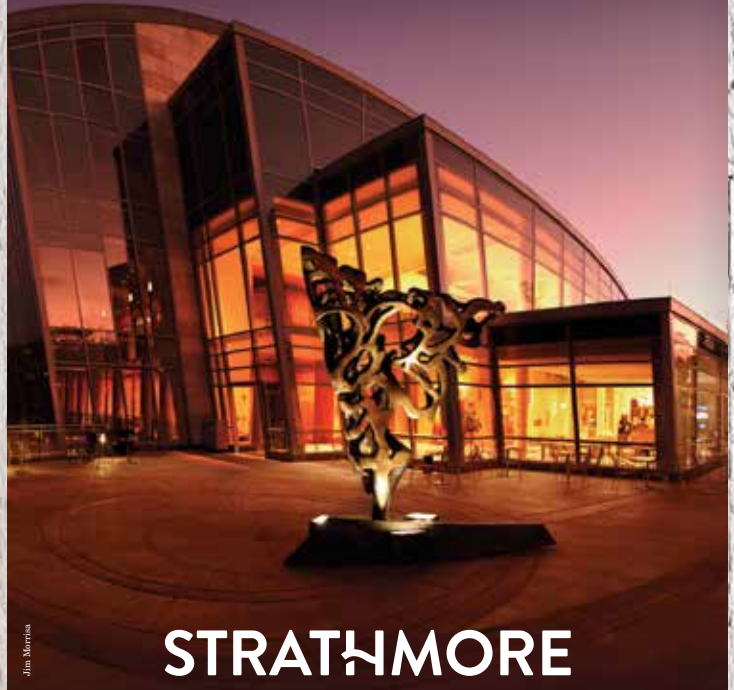

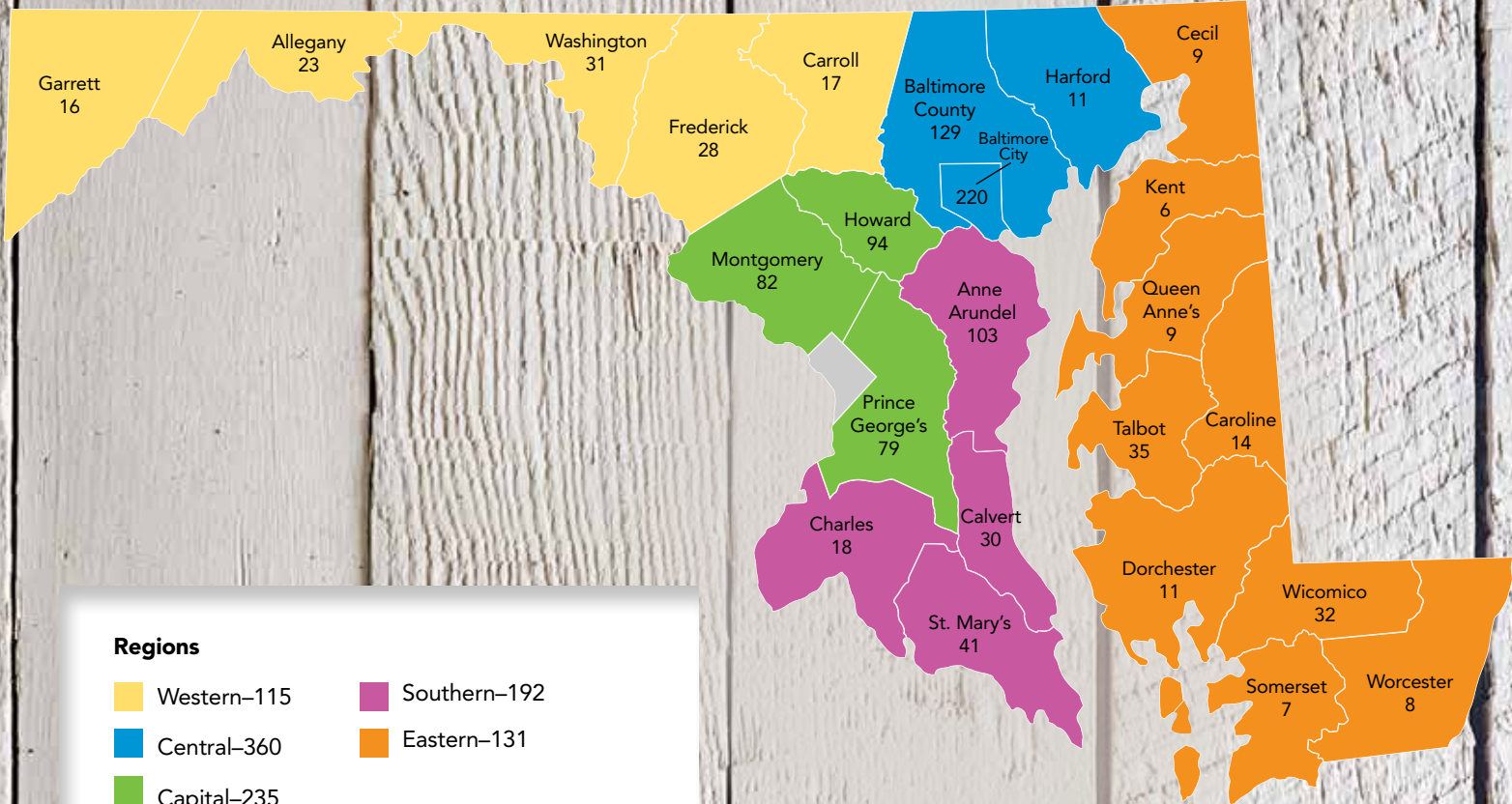

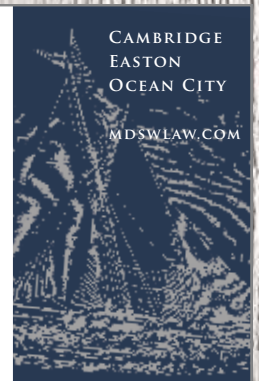
